**SPEC SHEET FOR:** 

The existing furnace does not function properly and needs to be replaced.

Install new Hi-Efficiency Furnace of proper size to heat the amount of square footage that is in this dwelling. Install proper ventilation line and make up air as required by Furnace specifications. Provide condensate pump and reservoir and attach to existing plumbing drain. Provide a new designated electrical service line from panel just for the furnace (unless existing feed is sufficient and meets Code). Examine all heat runs and cold air returns to assure that they are sealed properly and do not leak. Provide at least one heat run to each habitable space in the house and install damper type registers in each of these locations, including the bathroom and basement. Patch hole in the chimney where existing exhaust pipe enters to assure that fumes do not penetrate. Install new programmable thermostat and locate it in a central location of the house. Include 3 or 4 extra filters.
