VEHICLE BID SALE NOTICE

Sealed bids will be accepted in the Manistee County Controller/Administrator's Office, Courthouse, 415 Third Street, Manistee, Michigan 49660, until 4:00 P.M. on Monday, July 8, 2019 for the following former Police vehicles:

- ITEM #1: 2011 Ford Crown Victoria, 4-door, Black/White, 93,066 miles, (VIN #152114), partition (cage) between front and back seats, runs and drives, will need a new battery. Minimum bid \$3,000
- ITEM #2: 2011 Ford Crown Victoria, 4-door, Black/White, 107,650 miles, (VIN #152111), partition (cage) between front and back seats, runs and drives, will need a new battery. Minimum bid \$3,000
- ITEM #3: 2005 Ford Econoline Wagon (Van), White, 95,138 miles, (VIN #HA14391), partition (cage) between front and back seats, started up on 4-12-19, but then died – will turn over, but not start. Minimum bid \$1,000
- ITEM #4: 2007 Ford F-150 Extended Cab pickup, White, 131,413 miles, (VIN #FA61620), will not start, will not turn over. Minimum bid \$500

All vehicles will be sold "AS IS". The vehicles may be inspected at the Manistee County Sheriff's Office. Vehicle photographs are available on the County website at www.manisteecountymi.gov. Appointments to view the vehicles may be scheduled by calling the Sheriff's Office at (231) 723-8393, between 8 a.m. and 4 p.m.. All bids must include a certified check or money order totaling 20% of the total bid amount. The total bid amount must meet the minimum bid requirement. This deposit is refundable to all unsuccessful bidders. If the transaction is not finalized with the successful bidder, the 20% deposit will be forfeited by the bidding party. All bid envelopes should be plainly marked "Vehicle Bid - Item # ___" and marked with the item number of the vehicle on which a bid is being placed. All bids will be considered by the Board of Commissioners on Tuesday, July 16, 2019. Manistee County reserves the right to reject any or all bids without cause. Bids which do not comply with all criteria set forth in the invitation to bid will be subject to disqualification.
