Grant Projects

- **EGLE 2020 RECYCLING QUALITY IMPROVEMENT GRANT**
 - A purchase order has been submitted to ReCollect for the Waste Wizard subscription. A template will be provided by ReCollect for entering options for recycling, reusing, donating, or disposing of unwanted materials. Archer will provide the completed temple to ReCollect for populating the Waste Wizard. A widget will be provided for the website which will make the Waste Wizard search bar visible on the recycling page.
 - Archer has requested an extension of the grant to allow for use of funds authorized for fencing at the new Onekama site. The original grant contract period ends on March 31, 2021. An amendment to grant would extend the grant through July 31, 2021.
 - **Archer requests approval for amendment of the EGLE Recycling Quality Improvement Grant to extend the grant period from March 31, 2021 to July 31, 2021.**
- **MANISTEE COMMUNITY FOUNDATION LIMITLESS FUND GRANT**
 - Archer submitted a grant application on February 15, 2021. A \$5,000 request was made which will be applied towards the cost of fencing for the new recycling site at the County Fairgrounds. A match of \$5,200 was included in the request; \$4,200 from the EGLE Recycling Quality Improvement grant budget, and \$1,000 from the Manistee Conservation District. A funding decision is expected by April 30, 2021.
- EGLE Recycling Infrastructure Grant – release anticipated mid-March – Request to apply forthcoming.
- EGLE Rural Electronics Recycling Grant – release anticipated mid-March – Request to apply forthcoming.

Operations

- Archer is working on a plan for proposed recycling site at the County Fairgrounds and has had conversations with the Road Commission and has received Land Use Permit Application for Onkema Township from Manistee County Planning Department.

Program Development

- Archer and the Manistee Conservation District Director and Board Chair met virtually on February 19, 2020 to continue the conversation about potential partnerships/alliance for advancing recycling in Manistee County. A follow up meeting is scheduled for April 23, 2020.

FIRST AMENDMENT TO RECYCLING PARTNERSHIP GRANT AGREEMENT

This First Amendment to Recycling Partnership Grant Agreement (“First Amendment”) is hereby made and entered into on the date last executed below, by and between The Recycling Partnership, Inc., a Virginia corporation (“Partnership”) and the County of Manistee Michigan (“Grantee”), which are referred to collectively herein as the “Parties” and individually as a “Party.”

BACKGROUND

- A. Partnership and Grantee entered into that certain Recycling Partnership Grant Agreement (“Agreement”) dated April 24, 2020.
- B. The Parties wish to amend the Agreement to extend the Grant Period as set forth below.

In consideration of the promises stated in this First Amendment and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Parties agree as follows:

AGREEMENT

- 1. **Grant Period:** Section 2 of the Agreement is amended to extend the Grant Period through July 31, 2021.
- 2. **Effects; Conflicts.** Except as set forth in this First Amendment, all other terms and provisions of the Agreement are hereby ratified and confirmed and shall remain in full force and effect. In the event of any conflict between the provisions of this First Amendment and the provisions of the Agreement, the provisions of this First Amendment shall control.
- 3. **Signature Warranty:** Each of the undersigned represents and warrants that he or she is authorized to execute this First Amendment. This First Amendment may be executed in one or more counterparts, each of which shall be deemed an original, but all of which together shall constitute one and the same instrument.
