GRANT WRITER POSITION DISCUSSION

Julie Griffis, HR Generalist, requested to start the process on hiring the Grant Writer position which was budgeted in the 2021-22 budget year. On behalf of Ms. Sagala, Ms. Griffis noted that the position could start out on a contracted basis being funded with ARPA funds at a rate of \$50,000-\$54,000 per year. The position could work from home with the County supplying a laptop. Discussion of should the position be contracted, per grant, per hour? Could there be shared responsibilities in the job description since it is unknown how busy the person would be. Will this be for federal, state grants or for local entities? Would they write grants for Villages and Townships under a fee schedule? A job description should be created and that could include a fee schedule. When these questions are discussed and reviewed, the subject should then be brought to the Ways & Means Committee.




