P.A. 69 RECYCLING UPDATE

Recycling Program Report

Sarah Archer, Iris Waste Diversion Specialists, reviewed the Manistee County Green Team Recycling Program Report dated June 23, 2021 (Appendix A) and the Scrap Tire Event Summary (Appendix B) and the Household Hazardous Waste Collection 2021 Flyer (Appendix

C). There were no volume Report for June as of the date of the report. There was an article in the Manistee News Advocate regarding contamination and the Recycling Quality Improvement Grant status and impacts. There was a new contamination in Brown Township. Also, the Waste Advisor Tool is on the County website.

Scrap Tire Event Summary

A Scrap Tire Event Summary (Appendix B) was held on Saturday, June 26, 2021 from 10 a.m. – 2 p.m. at Bay Area Recycling for Charities, Kaleva, was reviewed. The weather was rainy for the Scrap Tire Event but there was still a good turnout. There were 1½ trailers filled with tires. Students from Bear Lake Schools were so helpful as well as the Bay Area Recycling for Charities (BARC) Staff. A second Scrap Tire Event will be held on September 2, 2021.

For the 2020 EGLE Quality Improvement Grant, Ms. Archer will be requesting a second extension for the remaining monies that are to be used for part of the Onekama Recycling site relocation.

The EGLE Recycling Infrastructure Grant will be mainly used for the Onekama Recycling site relocation. There is a new possible site on 8 Mile Rd., Onekama in Bear Lake Township (just outside of Onekama Township). The price is approximately \$10,000-\$20,000. The value is approximately \$8,500 and is a Special Use and Ag site. Although Bear Lake Township does not participate in the PA 69 Recycling program, it is hoped that this site will provide other recycling services, i.e., electronics, and maybe someday, Bear Lake Township would join the program. Ms. Archer will approach them again. The new proposed site does need some improvement. Although it has a paved area that could fit the bins and trailers, Brue Schimke, Maintenance Supervisor stated tree trimming is needed as well as a larger paved area (over the sand pit) and fencing with two (2) gates. Mr. Schimke will gather estimates for these improvements by the end of next week but estimates the improvements will cost approximately \$30,000 to \$35,000 plus the cost of the property of at least \$10,000. The cost of the project could be paid through some of the grant funding, a possible match from the Community Foundation for the EGLE grant and Onekama Township should be approached for funding since they are the entity that wants the location moved.

Recycling Drop Off Sites Collection Recycling Agreement expires the end of the year. A RFQ will be disbursed for bids and Ms. Sagala has that RFQ to review at this time. Pricing proposal verbiage change will be “not to exceed” and the RFQ to be all inclusive for extra summer service but not include contamination costs. Depending on the RFQ responses, it may be recommended to increase the recycling fee to \$20 (currently \$18) per year. It was noted that the increase could go to \$25 per year without voter approval.

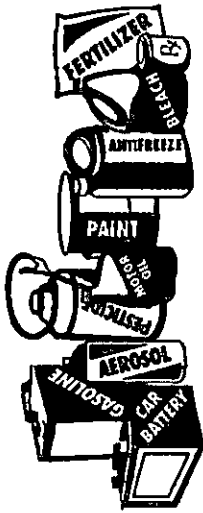
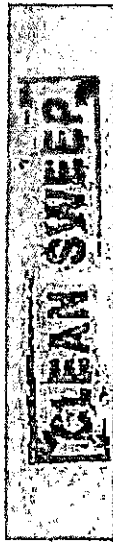

Disposal options for these items:

- Ammunition/Explosives: Sheriff's dept.
- Latex Paint: Latex paint is not considered HHW and therefore can be disposed of in the trash. Remove lid and add cat litter to dry out the paint prior to disposal.
- Tires: Scrap tire collections are scheduled for June 26 and September 25, 2021 in Manistee (location TBD), or accepted for a \$2.50 (car and light truck) fee at Manistee Tire.

If you miss our collection day, see below for locations that take HHW throughout the year:

- Motor Oil, Antifreeze, Transmission Fluid: Autozone, Advanced Auto Parts and Auto Value take these materials year-round.
- Large Appliances: Larry Bowling accepts free drop-offs. (231) 970-0012.
- Prescription Medications: Pharmaceuticals are accepted through the Red Med Box program. Red Med Boxes are located at Family Fare, Manistee City Police, Manistee Sheriff's office, and The Little River Band of Ottawa Tribal Police Station.

Frequently Asked Questions

Who can use the program?

Manistee County residents only. Hazardous waste will not be accepted from businesses except for pesticides in which case pesticide users such as agribusinesses, greenhouses, nurseries, and golf courses can use this service.

Which appliances will be accepted?

Small appliances such as microwaves, small refrigerators, dehumidifiers, and window air conditioners. We also accept large appliances including full-size refrigerators, stoves, and freezers. There is a \$10 fee for items containing Freon.

Which electronics will be accepted?

TVs, DVD and CD players, VCRs, radios, phones, gaming systems, answering machines, fax machines, etc. Computers and computer accessories are also accepted including desktop and laptops, keyboards, modems, printers, scanners, and speakers.

Is there a limit to how much I can bring?

Pre-registration is required for amounts exceeding 200 pounds. Please call the Conservation District - (231) 889-9666, extension 3.

Can I drop off HHW before/after the event?

No. Please drop off hazardous waste at collection sites only during scheduled hours. This is an annual event held the 3rd Saturday of August each year.

Is there a fee on collection day?

Donations are crucial to help cover the \$60,000 it takes to host the event in three counties. Suggested minimum donation of \$10 is appreciated!
