

## How to utilize maps through LIAA

1. Go to: [www.manisteecountymi.gov](http://www.manisteecountymi.gov)
2. Go to “Department” and then to “Equalization Department”.
3. Click on “Property Search” and follow the link provided.
4. Enter Parcel Number, Owner Information, or Street Address to search for property.  
\*\*\*Use **ONLY** one of the options.
